Subject: Resolution #2022-02 Budget Amendment 2021-2022 Fiscal Year

## Overview

The Districts final audited financial statements for the year 2020-2021 were presented at the April 19th, 2022 meeting. The 2021-2022 budget requires being amended to reflect the final audited balance forwards.

It has also been recommended that we do amendments to eliminate the debt owed by West Manatee Fire & Rescue on Station 1, located at 407 67th Street West, Bradenton, Florida 34209.

Attached is a completed detailed budget that was approved on September 7<sup>th</sup>, 2021 and outlining the increases/decreases for certain line items. In the revenue section, we have increased the amount of Taxes, Fees and Funds that we are expected to receive for the year. There were also reimbursements that were not budgeted for that we received, so those were included as well.

The expenses were updated to reflect reduced wage expectations for reserves and chaplains, reduced training expectations and reduced utility expectations based on current year-end projections. The main area of change was in the Debt Services category. The debt services expenses increased in the amount of \$758,193.74 for the purpose of paying off the debt owed on Station 1. Funds were reduced from our Unassigned Fund to assist in this payoff.

### Recommendation

West Manatee Fire Rescue District staff recommends adoption of Resolution #2022-02 Fiscal Year 2021-2022 Budget Amendment.

- 1. The Budget Amendment for Fiscal Year 2021-2022 is adopted.
- 2. This resolution shall take effect immediately upon its adoption.


